BACKGROUND:

The Santa Cruz County Sherriff Department agrees to assist our contract security company during events when requested by 14th DAA management.

FISCAL IMPACT:

This is a pay as we go – as needed - not to exceed contract for up to \$13,000.00. Increased from \$11,000 last time as we project the number of rental events will continue to increase.

That the Board approves a motion to execute contract with Santa Cruz Co. Sherriff's Department to assist with Interim Event security from July 1, 2014 through June 30, 2015.

EXHIBIT A (Interagency Agreement)

SCOPE OF WORK

1. Santa Cruz County Sheriff's Office agrees to provide the following services:

Contractor agrees to act as Security Liaison for the 14th District Agriculture Association and Fairgrounds Security for Interim Events (i.e. wedding receptions, quinceaneras, etc.) at the Santa Cruz County Fair located on the fairgrounds at 2601 East Lake Avenue, Watsonville, CA. 95076-1498. Contractor agrees to assist fairgrounds with security problems that may arise during Interim Events. Contractor's obligation to indemnify, defend and save harmless shall no apply to any claims or losses accruing or resulting to any person, firm, or corporation, including Contractor's Deputy Sheriff's, who may be injured or damaged by the intentional acts.

2. 14th District Agriculture Association/Santa Cruz County Fair agree to provide the following services:

The 14th DAA agrees to pay the Santa Cruz County Sheriff's Office \$100.00 per hour at each scheduled interim event (see above). The maximum amount paid will be \$13,000.00 per year from account 52300.

EXHIBIT B (Standard Agreement)

BUDGET DETAIL AND PAYMENT PROVISIONS

1. Invoicing and Payment

- A. For services satisfactorily rendered, and upon receipt and approval of the invoices, the State agrees to compensate the Contractor for actual expenditures incurred in accordance with the rates specified herein, which is attached hereto and made a part of this Agreement.
- B. Invoices shall include the Agreement Number and shall be submitted in triplicate not more frequently than monthly in arrears to:

2. Budget Contingency Clause

- A. It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.
- B. If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either cancel this Agreement with no liability occurring to the State, or offer an agreement amendment to Contractor to reflect the reduced amount.

3. Prompt Payment Clause

Payment will be made in accordance with, and within the time specified in, Government Code Chapter 4.5, commencing with Section 927.

EXHIBIT E (Standard Agreement)

Notwithstanding Indemnification provisions contained in Exhibit C-GENERAL TERMS AND CONDITIONS 5. INDEMNIFICATION, Contractor's obligation to indemnify, defend and save harmless shall not apply to any claims or losses occurring or resulting to any person, firm, or corporation, including Contractor's Deputy Sheriffs, who may be injured or damaged by intentional acts or sole negligence of the State, its officers, agents, or employees.
